The Town Commission meeting was called to order at 9:00 a.m.

The Ordinances were read by Town Attorney Davis.

Commissioner McMackin had questions about tunnels. There was discussion about what is allowed, what has been done in the past, variances, and FEMA flood stage elevation. Commissioner McMackin also suggested adding language that the resident building the tunnel is to cover additional costs for traffic control.

Building Official Tomasik gave an overview of the discussions with FDOT regarding tunnels. There was discussion of the 1890 & 1900 S. Ocean Blvd. tunnel timeframe, road closures, and fire rescue response.

Town Attorney Davis stated the changes could be made and brought back for second reading.

Mayor Pro Tem Bonner made a motion to recommend approval of Ordinance #395 with revisions to the Town Commission on first reading. Commissioner Knobel seconded the motion which prevailed by the following vote:

i. *VAR 25-2 – 1540 Paslay Place. – Frank Lynch presented the application. Mr. Hanbury of Hanbury Construction was available for questions. Mr. Lynch provided a seven page exhibit and handout for the commissioners. Commissioner McMackin asked the length of the dock. Mr. Lynch explained the length is 38' from the mean high water line.

10. Mayor's Comments, Town Commission Comments, Town Manager Comments

Mayor Deese had no comments and opened the floor to the other Commissioners.

Commissioner Kulwin asked about the beach committee. Town Manager Marmer explained that they will have the Town consultant, Aptim, present the first phase at the May meeting.

Building Official Tomasik discussed the need to revise Town Code to meet the current Florida Building Code.

Commissioner Knobel commended the library's recent CPR classes.

Town Manager Marmer mentioned that he had met with the Town Manager of South Palm Beach to explore the idea of providing building services to them.

Town Manager Marmer explained at the direction of the Commission, the Town had engaged a firm to conduct a salary study. He notified the Commissioners that he expected the results for the May meeting as well as potentially a presentation by FPL for the underground electric project.

Town Manager Marmer announced staff was starting back up the Town Newsletter, The Manalapanian, which he expects to go out in the near future.

Commissioner Bonner asked about the sewer project and utility coordination. Town Manager Marmer stated Mock Roos is working on the plans and grant funding. Mr. Marmer discussed a possible referendum. Mayor Deese commented that residents were previously opposed to the \$25-\$35k fee and it sounds like the new fee will be approximately the same. There was also discussion regarding planning for it now, the availability of State funds, and flexibility for the residents to connect in the future.

Lastly, Chief Jeff Rasor told the commission that there will be a life saving award at the next meeting.
